Action

Description

• Award a contract for the design and construction of 19th Street Cargo Redevelopment.

Justification

- Based on current usage and forecast growth, the existing air cargo facilities at the Airport will be at or near capacity in 2025.
- A site at 19th Street and West Airfield Drive which has both airfield and roadway access, is ideally suited for redevelopment for additional air cargo facilities.
- This contract will provide for the demolition of an existing structure, and the design and construction of two new warehouse buildings, aircraft taxiway and hardstand, vehicle parking areas and associated infrastructure.
- It is anticipated that these new cargo facilities will provide enough additional capacity to accommodate air cargo growth through 2035.
- The 19th Street Cargo project has been approved by the Cities of Dallas and Fort Worth as a PFIC project.

D/S/M/WBE Information

- The annual goal for the M/WBE Program is 31%.
- In accordance with the Board's M/WBE Program, the M/WBE goal for this contract is 20% for design and 33% for construction.
- JE Dunn Construction has committed to achieving 21.5% M/WBE participation for design utilizing the attached list of M/WBE firms and 33% M/WBE participation for construction and BDDD is receipt of their compliance plan to achieve its commitment upon the release of their bid packages.

Action

That the Chief Executive Officer or designee be authorized to execute a Local Project Advance Funding Agreement (LPAFA) Amendment with Texas Department of Transportation (TxDOT) to include an additional \$5,965,702, for the construction of the East West Connector Roadway, for a total funding amount not to exceed \$28,810,026.

Description

• Execution of the subject funding agreement is required by TxDOT for the Airport to receive funds for the East West Connector Roadway from a federal grant administered by North Central Texas Council of Governments (NCTCOG).

Justification

- The \$28,810,026, is a \$5,965,702 increase over the previously approved \$24,225,425 (Reference Resolution 2022-90-217).
- Since the construction bid price came in higher than the budget, NCTCOG provided additional federal funds to close the funding gap, allowing the project to move forward.
- The new roadway will provide the following:
 - ♦ Relieves South Airfield Drive traffic and improves safety by reducing traffic through the International Parkway Interchange
 - ♦ Creates new access from the west to Southgate Plaza, the Rental Car Center, and Passport Park
 - Provides improved access to adjacent existing and future tenants
 - ♦ Provides an east-west thoroughfare between state highways SH 360 and SH 161

D/S/M/WBE Information

- The TxDOT DBE goal for this contract is 9%.
- Mario Sinacola & Sons Excavating, Inc. has committed to achieving 9.14% DBE participation on this contract. No work and payments have been made to date for this contract therefore no diversity participation has been reported.
